Applicants must submit proof of receipt of a JD or LLB degree at the time the application is filed. Your attention is called to the following from Rule 402(c)(3), SCACR, "An applicant ...who has not graduated may sit for the UBE in South Carolina if the law school certifies in writing that the applicant has completed all requirements for graduation by July 10th for the July examination of February 10th for the February examination; the applicant must provide proof of graduation by April 1st following the February examination or October 1st following the July examination [.]"
